**RULES AND REGULATIONS MADE UNDER THE ROAD PASSENGER TRANSPORT AUTHORITY STATUTE  
No. 02 OF 1996 OF THE SOUTHERN PROVINCE PROVINCIAL COUNCIL**

RULES and Regulations enacted under Section 41 of the Road Passenger Transport Authority Statute No. 02 of 1996 of the Southern Province Provincial Council, are hereby notified for the information of the public.

#### Rules

01. These Rules shall be cited as 'Rules No. 01 of 2009 on fees and other charges recoverable on permits for passenger transport services.'
02. These Rules are an amendment of relevant fees on subject matters listed under Schedule No. 04 of Rules No. 01 of 1998 of the Southern Province Provincial Council Indicating the fees stipulated by the Authority.

#### SCHEDULE 04

*Fees stipulated by the Authority*

Fees payable for any function relating to a subject matter listed under Column (I) of this Schedule shall be the amount stated against it in the corresponding Column II.

1. Application fee for a permit	10000
2. Licence Fee on a road Passenger Transport Permit	3,00000
3. Surcharge for failure to extend a road passenger transport permit on the due date (for one month or part thereof)	25000
4. Endorsement of a by-road (for one year or part thereof)	1,00000
5. Permit book relating to the Passenger Transport Service (issue of duplicate)	50000
6. The permit label relating to the passenger transport service (duplicate)	20000
7. Special tour licence (for single day)	20000
8. Special tour licence for tours extending beyond one day (for each extra day)	10000
9. Temporary licence (one day)	10000
10. Settlement of a licence on a person not holding a licence	50,00000
11. Settlement of a licence on an operator already in possession of a licence (offer of 25% discount)	37,50000
12. Transfer of licence to a person legally entitled to same consequent on death of licence holder (Wife/Husband or Children)	3,00000
13. Transfer of licence to a person not entitled to same legally, consequent on death of licence holder (Fees stated under 10 and 11 above shall apply. The fee on the passenger transport service permit shall be added to the fees referred to under 10, 11, 12 and 13)	10000
14. Issue of a duplicate of the bus time table	10000
15. Amendment of bus time tables at the instance of operators (where the Authority concurs) for one bus	25000
16. Issuing of additional fare tables	5000
17. Amendment to duty rosters at the collective request of operators (per bus)	10000
18. Change of buses in the passenger transport permit	1,00000
19. Changes to a service stipulated in the passenger transport service permit (at the instance of operator)	2,00000
20. Service or arrival charges (for one month or part thereof)	50000
21. Delays in the payment of service or arrival charges shall be subject to a surcharge of 10% (for one month or part thereof)	
22. Issue of copies of time tables or other computerised data (for one print sheet)	2500
23. Fees chargeable for conducting checks on a bus for six days a month and providing the owner with inspection reports (with the concurrence of the operator)	30000

These Rules shall come into force as from 01st June 2009.
