01. These rules shall be cited as 'Rules No. 01 of 2015 on fees and other charges recoverable on permits for passenger transport service',
02. These Rules are an amendment of relevant fees on subject matters listed under Schedule No. 04 of Rules No. 01 of 2009 of the Southern Province provincial council indicating the fees stipulated by the authority.
